All PA4 and PA4G qualified staff who apply granular pesticide. The course will appeal to those who wish to update their knowledge on nematicide stewardship. It presents best practices developed by the Nematicide Stewardship Programme (NSP), and is the basis of the Nematicide Application Protocol in the Red Tractor crop specific protocols for potatoes, onions, parsnips and carrots.

The Nematicide Stewardship e-learning course has been developed for operators who have attended workshops in the past, to ensure they remain up to date with the latest advice. Operators should complete the Nematicide Stewardship e-learning course within three years of attending the face to face Nematicide Stewardship course.

## Content:

**Module 1:** Do I need to use nematicides and am I qualified to use them?

This module is a combination of video, slide show and interactive activities leading participants through the code of practice for the use of nematicides and asks the question who can apply nematicides legally and are you qualified to do the job? It also asks what is a nematode, looks at integrated management practices for the successful and sustainable management of PCN and FLN and gives the latest advice on soil sampling and nematode testing.

**Module 2:** Use of nematicides, best practice (Available late 2018)

Fully interactive module using a product label to explore what the content of the label actually tells you. It explores in more detail aspects of how the adoption of correct stewardship is important for operator and environmental safety.

**Module 3:** Setting up and calibrating applicators (Available late 2019)

Using videos this fully interactive module looks at nematicide applicators and how to maintain, store and calibrate them. The second element of the module looks at the safe application of Nematicides and how to deal with spillages when filling and applying nematicides.
